### Your Responsibility

Once you are registered, you have a legal requirement to notify the Council of any changes to your residential, postal or work address within one month of the change. You can do this by logging into "My Profile" on the website.

### COUNCIL'S RESPONSIBILITY

The primary responsibility of the Council is to protect the health and safety of the New Zealand public by ensuring practitioners registered in the professions of medical laboratory science, and anaesthetic technology are competent and fit to practise.

# Communication with the Council's Staff

The Council appreciates the effort most practitioners are going to in providing their CPD to the Council's staff and acknowledges that that this can be a stressful time for those who have been selected for audit. However, the Council would like to remind a small number of practitioners that engaging with Council staff in a disrespectful manner damages your professional reputation and can bring the whole profession into disrepute. The Council's *Code of Ethical Conduct* outlines a practitioner's professional obligation to communicate in a respectful and collaborative manner with colleagues both within the profession and the wider healthcare setting, which includes the Council's staff.
