# Introduction from the CEO

Kia ora koutou

Ko Sue Calvert tōku ingoa / My name is Sue Calvert and I have recently been appointed as the Chief Executive of the Medical Sciences Council. I am honoured to take up the role and would like to acknowledge the great legacy that the Council's long-serving previous CEO, Mary Doyle left.

I have come to this role with a background in health and regulation. After graduating from the University of Canterbury in the 1980's, I started my working life in the business sector. However I very quickly changed direction and have been working in health for more than 30 years. I have worked as a midwife in a number of roles across the clinical practice, research and education areas. Over the last 14 years I have held a number of regulatory leadership positions including professional advisor, registrar and Chief Executive. I come to this role at the Medical Sciences Council with a solid understanding of the health professional regulatory environment and the importance of public safety.

As regulators our purpose is to protect the public by ensuring that practitioners are competent and fit to practise their profession. We do this by setting standards for entry to the profession and requiring clinicians to engage in ongoing development. Having identified the demands on clinicians and the changing and complex clinical environment in which they practice, my doctorate focussed on how a group of practitioners maintained their ongoing competence to practise their profession. My research highlighted, at the time, that clinicians identified areas in which they needed to develop their practice and managed issues such as resourcing and availability of education in order to maintain their competence. I am aware that the past few years have brought more challenges to health professionals. It has also highlighted the crucial role that you play in the provision of care to the public. I was recently at function where I was able to speak with students from a number of health professions. Their energy enthusiasm and desire to make a difference to the experience of whānau was inspiring.

In order to be effective in my role as Chief Executive I see it is vital to create and maintain effective relationships across the sector. While I have only been in this role a few weeks, I am considering strategies that can enhance stakeholder engagement and communication. The Council has a solid workplan which includes work on cultural competence as well as a review of the scopes of practice frameworks and I look forward to engaging with you as we progress this work.

I want to take this opportunity to acknowledge those of you who have been impacted by the recent weather events that have led to the state of emergency. I also want to acknowledge those who have provided assistance in support of colleagues. We are currently in the midst of our practising certificate renewal cycle and my team are doing a great job of processing your applications. While many of you have already applied for and been granted your APC, if you have been impacted by the cyclone, please do not hesitate to contact the Council if you need to speak with us about your application.

## **APC** renewals

The renewal process for your 2023/2024 APC opened on 14 February 2022 and remains open until COB 31 March 2023.

#### **RESETTING YOUR PASSWORD:**

# MSC Audit Reminder

As a reminder, there will be **NO AUDIT** in 2023. The next audit will be completed in 2024, and will cover the 2022-2023 biennium. However, all practitioners are still required to engage in CPD. In readiness for the 2024 audit, practitioners must ensure their two years of CPD for 2022 and 2023 meets the minimum hours requirement:

- Medical laboratory scientists: 40 hours over the biennium. A minimum of 15 hours must be completed in any one year.
- Medical Laboratory Technician or Medical Laboratory Pre-Analytical Technician: 24 hours over the biennium.
- A minimum of 9 hours must be completed each year.
- Anaesthetic Technicians: 40 hours over the biennium. A minimum of 15 hours must be completed in any one year.

What you would need to do for the 2022-2023 biennium:

- Undertake the full amount of CPD hours specified (40 hours for MLS and ATs, 24 for MLT /LPAT); and
- Ensure you keep a clear record of the activities you have undertaken.

E.g., if you are an MLS or AT and have only completed 15 hours of CPD in 2022, you will need to complete 25 hours in 2023, in order to meet the 40 hours required for the 2024 audit.

If you are an MPLAT or MLT and completed 9 hours of CPD in 2022, you will need to complete 15 hours of CPD in 2023 in order to meet the 24 hours required for the 2024 audit.

# **Protected Titles**

The Council encourages employers to carefully consider how to title a role, especially when protected titles are at risk of being used inappropriately. The use of protected titles: Medical Laboratory Scientist, Medical Laboratory Technician, Medical Laboratory Pre-Analytical Technician, Phlebotomist, Donor Technician, Specimen Services Technician and Anaesthetic Technician are titles that are only reserved for practitioners who are registered with the Council and hold a current annual practising certificate. Having the correct title is important because it informs patients and other healthcare professionals who is providing care and in what capacity.
