#### YOUR RESPONSIBILITY

Once you are registered, you have a legal requirement to notify the Council of any changes to your residential, postal or work address within one month of the change. You can do this by logging into "My Profile" on the website.

The primary responsibility of the Council is to protect the health and safety of the New Zealand public by ensuring practitioners registered in the professions of medical laboratory science, and anaesthetic technology are competent and fit to practise.

It was a pleasure to meet a number of practitioners from across Aotearoa and to listen and talk with them about their work. I was impressed with their passion for their professions. As practitioners maintaining competence is integral to the health and safety of the public, the Council sets the minimum standards required of all practitioners for continuing development which not only includes clinical and technical competence, but also cultural competence. The Council is developing a list of cultural competence education resources for practitioners that will be added to the website in due course.

As Chief Executive I take my responsibilities for the health, safety and wellbeing of my staff very seriously. Recently, there have been incidents when communication with the staff team by a small number of practitioners has not been of the standard required.

My request to practitioners is that when writing to or phoning the Council that the staff are treated with respect. They are there to help you with your application processes and questions, and I expect this is conducted in a professional manner by practitioners and staff.

The Council's Code of Ethical Conduct outlines a practitioner's professional obligation to communicate in a respectful and collaborative manner with colleagues both within the profession and the wider healthcare setting, which includes the Council's staff. Any abuse directed towards staff may result in you being referred to the Council.





#### **Devon Davies - Communications and Projects Coordinator**



The below graphs outline the total number of approved registrations between 1 April 2022 and 31 March 2023 and which registration pathway they were approved through:

MLPAT: Medical Laboratory Pre-Analytical Technician

MLT: Medical Laboratory Technician

MLS: Medical Laboratory Scientist

**QMLT:** Qualified Medical Laboratory Technician certificate from the New Zealand Institute of Medical Laboratory Science.

**Internationally Qualified:** Overseas qualification which was assessed and considered substantially equivalent to the New Zealand prescribed qualification.

**Diploma in Applied Science:** New Zealand Diploma in Applied Science (Level 5) from ARA Institute of Canterbury.

**Bachelor of Science:** New Zealand Bachelor of Science degree in a relevant biological science which was assessed and considered substantially equivalent to a New Zealand prescribed qualification.

**Other:** New Zealand qualification e.g., a qualification in a relevant biological science which was assessed and considered substantially equivalent to a New Zealand prescribed qualification.

**Online Examination:** When an applicant's overseas qualification is assessed as not being substantially equivalent to the NZ prescribed qualification, an applicant may be offered the opportunity to sit a registration examination.

**BMLSc:** Bachelor of Medical Laboratory Science from Auckland University of Technology or the University of Otago.

**Graduate Diploma:** Graduate Diploma in Science from Auckland University of Technology or the Postgraduate Diploma in Health Science (Medical Laboratory Science) from Massey University.

**Masters/PhD:** A relevant New Zealand Masters or PhD qualification which the Council has assessed and considers meets the requirements for registration.

**AUT Diploma/Graduate Certificate:** Diploma in Applied Sciences (Anaesthetic Technology) or the Graduate Certificate in Applied Sciences (Anaesthetic Technology) from Auckland University of Technology.

**Internationally Qualified UK:** Qualification in Operating Department Practice from the the UK.

## MLS Scope of Practice Review Update

The Council's staff have recently met with three main stakeholder groups – education providers, unions and professional bodies to discuss the medical labratory science scope of practice review and staff are currently formulating their advice for the Council for discussion at their August meeting. We expect following this meeting futher updates will be provided.

# **Continuing Professional Development**

As a reminder, there will be **NO AUDIT** in 2023. The next audit will be completed in 2024, and will cover the 2022-2023 biennium. However, all practitioners are still required to engage in CPD. In readiness for the 2024 audit, practitioners must ensure their two years of CPD for 2022 and 2023 meets the minimum hours requirement:

	Minimum CPD hours over the biennium	Minimum CPD hours in any one year	What you need to do for the 2022-2023 biennium	
MLS	40	15	Undertake the full amount of CPD hours specified and ensure you keep a clear record of the activities you have undertaken.	If you only completed 15 hours of CPD in 2022, you will need to complete 25 hours in 2023 in order to meet the 40 hours required for the 2024 audit.
MLT/MLPAT	24	9		If you only completed 9 hours of CPD in 2022, you will need to complete 15 hours in 2023 in order to meet the 24 hours required for the 2024 audit.
AT	40	15		If you only completed 15 hours of CPD in 2022, you will need to complete 25 hours in 2023 in order to meet the 40 hours required for the 2024 audit.
